At St John's C of E Middle School Academy we recognise the challenges that families face in bringing up children. There may be times when you need extra help and support. If this is the case please come and talk to us. There are many ways in which we can help as outlined in this offer of early help. We can also help to plan specific support for families in the forms of Plans or [Early Help Assessments](#) where we can work together to set and achieve outcomes.

The diagram below shows the range of needs at different levels. We use this graduated approach to make sure we provide the best support for different families' individual situations.



Providing early help to our pupils and families at St John's C of E Middle School Academy means we are more effective in promoting support as soon as we can. Early help means providing support as soon as a problem emerges, at any point in a child's life, from the foundation years through to teenage years.

At St John's C of E Middle School Academy, our SILT (Safeguarding and Inclusion Leadership Team) meet once a fortnight to discuss any concerns. This team, who have all received 'Targeted 2 Training,' includes:

Each week our Senior Leadership Team (SLT) meet with Heads of Year who have a pastoral responsibility for the year group. All Heads of Year have received ‘Targeted 1 training’

Year 5 – Mr Owen

Year 6 – Mrs Hirons

Year 7 – Mr Hirst

Year 8 – Miss Bourne

Our class teachers receive safeguarding training which is refreshed and updated on a frequent basis with a full refresher every year. Any concerns raised by staff relating to children in their class are shared with the head of year allowing for us to act in the appropriate way to support the child, and family. Initially, any concerns that you may have should be discussed with the class teacher. Epraise can be used to privately message the teacher should you need to arrange a meeting.

Heads of Year meet with the teachers in their year group on a weekly basis. Safeguarding is a standing item on the agenda.

At these meetings we discuss:

How the child presents	Behaviour	Attitudes to learning
Friendships	Family issues	Additional needs
Any support they receive	General progress	Other agencies involved

This allows us to identify any pupils and families that would benefit from early help and allows us to help them access the services in the school and beyond the school.

Pastoral support needs are met initially by the class teacher, however, pupils needing more specific support can be referred by the class teacher.

Our dedicated team of teaching assistants are deployed by the SENCo based on supporting the various needs of our pupils. Further information can be found in or SEND Offer.

PREVENT TRAINING – Radicalisation.

Mr Medway has received PREVENT training and has trained the team on how to identify the early stages of radicalisation and what to do. We follow the mantra; NOTICE CHECK SHARE.

Child Sexual Exploitation

All staff at St John’s C of E Middle School Academy have been trained to identify early cases of child sexual exploitation. At school we use the [CSE Screening tool](#) if we have concerns.

Female Genital Mutilation

All staff have received training on FGM. Teachers know how to identify if a child may be at risk. They know the signs to look for and most importantly how to refer, following the schools safeguarding procedures.

At St John's C of E Middle School Academy we meet the needs of our children through a variety of ways:

- Closely monitoring and having conversations about Attendance
- Safeguarding processes of reporting and building up a picture
- Behaviour for Learning
- Pastoral Support where changes and needs are noted
- SENCO support
- Designated Safeguarding Lead who can see the full picture of concerns raised (DSL)

At St John's C of E Middle School Academy we meet the needs of our children through a variety of ways:

Pupil Voice – pupils are actively encouraged to speak about any concerns they have to a member of staff or to our pastoral team. In lessons children are taught to speak openly about their emotions. Pupils know the staff take all their concerns very seriously.

- Children's questionnaires ascertain if they feel happy and safe
- E-safety assembly delivered to all pupils
- E-safety presentation offered to parents
- Assemblies for E-Safety, SEXTING and other relevant Topics are conducted by school staff or external agencies.
- Delivery of support groups tailored for our children's needs
- Our school council have a huge role in pupil voice and they meet with Mrs Elwell
- Staff CPD around pupil wellbeing and how to support them.
- Senior Leadership Team presence during less structured times
- School nurse termly drop in appointments to discuss pupil wellbeing to pupils.
- The DSL meets with a community school and police group, on a termly basis

ATTENDANCE

Mrs Martin is the lead on attendance, supported by Mrs Elwell-Thomas and Mr Medway. She monitors this weekly and follows our attendance policy to support pupils and families with attendance below 90%. The aim is to offer help and solutions to any problems. Parents can access their child's attendance live via Epraise.

The school operates a first day response system.

SAFEGUARDING

- All teachers and staff know how to identify and report concerns, via staff

training on induction and our regular updates on safeguarding.

- Child protection files are kept in an electronic secure format by the DSL.
- ATTENDANCE team follow missing from education guidance.
- All new staff complete safeguarding inductions.
- We have a designated teacher for children in care.

- We have a record of annual recording that all staff have read Keeping Children Safe in Education (Sep 2018).

Behaviour for Learning at St John's C of E Middle School Academy

- The school encourages and rewards pupils using Epraise on a lesson by lesson basis
- Pupils are rewarded by Give of Your Best days and other entitlements can be purchased and awards given through Epraise for meeting certain criteria.

Our school behaviour policy is followed for pupils displaying unwanted behaviours.

Parents can access their child's behaviour for learning record via Epraise.

Pastoral Support

Allocated staff work with pupils and families to support their needs whilst also signposting them to relevant agencies. With families consent, we can refer families for further family support in the form of Early Help or Targeted Support ([Click for details](#))

SENCO

Mr McEvilly works with children and families with additional needs and can signpost parents to many different agencies.

Designated Safeguarding Lead (DSL)

The DSL (Mr Medway) ensures rigorous and robust systems are in place within the school to ensure the safety of all of our children.

In **Keeping Children Safe in Education 2018** it makes it clear that ALL staff should be aware of their local early help process and understand their role in it. In addition, this statutory document makes it clear that any child may benefit from early help, but all school and college staff should be particularly alert to the potential need for early help for a child who:

- Is disabled and has specific additional needs;
- Has special educational needs (whether or not they have a statutory education, health care plan);
- Is a young carer;
- Is showing signs of being drawn in to anti-social or criminal behaviour, including gang involvement and association with organised crime groups;
- Is frequently missing/goes missing from care or from home;
- Is misusing drugs or alcohol themselves;
- Is at risk of modern slavery, trafficking or exploitation;
- Is in a family circumstance present challenges for the child; such as substance abuse, adult mental health problems or domestic abuse;
- Has returned home to their family from care;
- Is showing early signs of abuse and/or neglect;
- Is at risk of being radicalised or exploited;
- Is a privately fostered child.

Everyone needs help at some time in their lives and therefore an ethos of early help is important for any school or PRU.

The coordinated St John's C of E Middle School Academy offer of Early Help is outlined in the table below. We believe that early interventions for children or families, in many cases, will prevent children from experiencing harm.

All St John's C of E Middle School Academy staff must be aware of the school offer of early help. At all times, staff should consider if there is any offer of early help that we can make in order to help a child thrive.

We also liaise with other agencies and people within the local community. In the table below are some National organisations that can support children, young people and their families

<p>What is our Early Help Offer?</p>	<p>Early help guidance for professionals</p> <p>What is Early Help?</p> <p>Early Help means providing support as soon as a problem appears, to stop it from getting worse. This could be at any point in a child's life, from birth to the teenage years.</p> <p>Anyone can provide early help – you don't need to be an expert professional. Early help is not about passing the issue on to an expert, but thinking about what is the best support you can offer.</p> <p>You can provide effective support by:</p> <ul style="list-style-type: none"> • listening • working with other people who could help • finding out about specialist agencies who could help • filling out an Early Help Assessment with the person you are helping

<p>Home-school support</p> <p>Worcestershire Home Education Network</p>	<p>Home education is becoming an increasingly popular option for families in Worcestershire and we have a growing community that are able to offer each other support. Between us we have years of experience in educating children of all ages and are able to organise and put on a range of activities.</p> <p>We hold meetings usually at least weekly, throughout term time at various locations round the county-for example:</p> <ul style="list-style-type: none"> - <i>Social gatherings occur monthly in North Worcestershire for all ages, with both indoor and outdoor games plus organised activities such as climbing/zip-wires/grass sledging for 8+.</i> - <i>Monthly meeting in Worcester with games, music and crafts for all ages.</i> - <i>Monthly social meeting in south Worcestershire, including indoor and outdoor games, group music session and a drama group.</i> - <i>Bowling or Ice skating most months.</i> - <i>"Education group" workshops organised regularly. The police will consider all of the circumstances when considering the best response to a report of cyber bullying. They will assess how vulnerable the victim is and what resources are required to trace the offender via social networking sites that often operate abroad and to different legislation. Other services available are those provided by health, education, play and youth services as well as community resources provided by voluntary agencies.</p> <p>The CwD team offer services to those children and young people requiring additional resources in respect of their disability, where the disability has a profound impact on the child or young person’s life.</p> <p>An assessment will be offered where the child has a condition which is substantial, long lasting or permanent, is a physical and/or learning disability or a life limiting, life threatening condition. Domestic Violence Protection Order (DVPO)

DVPOs are a civil order that can be applied for by the police and granted by a magistrate. If granted, the order will immediately ban the perpetrator from

returning to a residence and from having contact with the victim for up to 14-28 days. This period of time allows the victim the opportunity to consider their options and allows agencies to provide intensive support to the victim / family. This Protection Order does NOT need the consent of the victim. A breach will result in the perpetrator being arrested. A free app for smartphones has been designed to protect both men and women from possible danger. Hollie Guard turns your smartphone into an advanced personal safety device at the touch of a button. If in danger simply shake your phone to generate an alert, your location, audio and video evidence of the incident will automatically be sent to your emergency contact via text and email. Shake it again and it sends out a high pitched alarm and the flash starts to strobe, in order to attract maximum attention. From the moment Hollie Guard is activated, your location is tracked and can be viewed in real time by your emergency contact. Evidence is not stored on the smartphone but on secure servers so that it can be used as future as evidence. Hollie Guard also contains many other features.

<p>Honour based violence (HBV)</p>	<p>Honour’ based violence (HBV) occurs when perpetrators believe a relative or other individual has shamed or damaged a family’s or community’s ‘honour’ or reputation (known in some communities as izzat), and that the only way to redeem the damaged ‘honour’ is to punish and/or kill the individual. ‘Honour’ based violence is a term that is widely used to describe this sort of abuse however it is often referred to as so called ‘honour’ based violence because the concept of ‘honour’ is used by perpetrators to make excuses for their abuse. There is a very strong link between ‘honour’ based violence, forced marriage and domestic abuse. The term ‘Honour Based Violence’ is the internationally recognised term describing cultural justifications for violence and abuse. Honour Based Violence cuts across all cultures and communities: Turkish, Kurdish, Afghani, South Asian, African, Middle Eastern, South and Eastern European for example. This is not an exhaustive list. Where a culture is heavily male dominated, HBV may exist. <p>Missing Children and Adults Strategy (vulnerable children and adults who go missing)</p>	<p>Every year an estimated 200,000 people go missing in the UK. In some cases, missing adults may have made a choice to leave and 'start their lives over again', but the vast majority of missing people, children and adults, are vulnerable and need protection and support. The strategy has three key objectives which provide the right foundations for any effective local strategy to tackle this issue: Prevention - reducing the number of people who go missing, including through prevention strategies, education work and early intervention in cases where children and adults repeatedly go missing Protection - reducing the harm to those who go missing, including through a tailored, risk-based response and ensuring agencies work together to find and close cases as quickly as possible at a local and national level Provision - providing support and advice to missing persons and families by referring them to agencies promptly and ensuring they understand how and where to access help. The police should be informed if any child or adult goes missing. The Missing Children and Adults strategy can then be referred to for further information and help.
