#### Introduction

At St John's C of E Middle School Academy, we recognise the challenges that families face in bringing up children. There may be times when you need extra help and support. If this is the case please come and talk to us. There are many ways in which we can help as outlined in this offer. We can also help to plan specific support for families in the forms of Plans or <u>Early Help Assessments</u> where we can work together to set and achieve outcomes.

Providing help and support to our pupils and families at St John's C of E Middle School means we can improve outcomes for children, families, and communities by getting support as soon as a problem emerges. The 'Offer' is for all children, as issues may arise at any point in a child or young person's life. It includes both universal, targeted or specialist services, to reduce or prevent concerns from growing or becoming too overwhelming.

Help and Support for Families can support children and their families who may be struggling with:

- Routines and family rules.
- Families who may not be eating heathy food.
- Keeping to a healthy lifestyle.
- Children who are caring for a family member.
- Children who may not want to go to school for different reasons.
- Disability within the family including children being a young carer.
- Children in the family who have special educational needs (SEND).
- Children who may become involved in anti-social or criminal behaviour.
- Children who go missing from home.
- Children or parents / carers misusing drugs or alcohol.
- Children at risk of being tricked, forced, or made to work in the criminal world.
- Children who may need support because they may live in a home and see drug or alcohol abuse or adult mental health problems.
- Children who have parents who argue a lot (and sometimes might hurt each, other) whether the parents live together or apart.
- Children at risk of being groomed to join groups which support illegal views.
- A privately fostered child (a child from another family living within your family home).

#### **Levels of Need**

The diagram below shows the range of needs at different levels. We use this <u>graduated approach from Worcestershire Children First</u> to make sure we provide the best support for different families' individual situations.



Providing early help to our pupils and families at St John's C of E Middle School Academy means we are more effective in promoting support as soon as we can. Early help means providing support as soon as a problem emerges, at any point in a child's life, from the foundation years through to teenage years.

#### **Processes**

At St John's C of E Middle School Academy, our SILT (Safeguarding and Inclusion Leadership Team) meet once a week to discuss any concerns. This team, who have all received 'Targeted 2 Training,' includes:

Mrs Gallinagh – Deputy Headteacher (Inclusion) – Designated Safeguarding Lead (DSL) Ms N Birmingham – Assistant Headteacher (Behaviour) - Deputy Safeguarding Lead Ms M Jarvis - SENDCo - Deputy Safeguarding Lead

Miss J Alexander – Early Help and Family Support – Deputy Safeguarding Lead
Mrs Sarah Butt – Emotional Literacy Support Assistant (ELSA)
Each week our Senior Leadership Team (SLT) meet with Heads of Year who have a pastoral responsibility for the year group. All Heads of Year have received 'Targeted 1 training'

**Year 5** – Mrs Hall

**Year 6 –** Mrs Hirons

Year 7 - Miss Bourne

Year 8 - Mr Boyd

Our class teachers receive safeguarding training which is refreshed and updated on a frequent basis with a full refresher every year. Any concerns raised by staff relating to children in their class are shared with the head of year allowing for us to act in the appropriate way to support the child, and family. Initially, any concerns that you may have, should be discussed with the class teacher. Epraise can be used to privately message the teacher should you need to arrange a meeting. The form tutor will contact you if they need to meet.

Heads of Year meet with the teachers in their year group on a fortnightly basis. Safeguarding is a standing item on their agenda. At these meetings we discuss:

How the child presents	Behaviour	Attitudes to learning
Friendships	Family issues	Additional needs
Any support they receive	General progress	Other agencies involved

This allows us to identify any pupils and families that would benefit from early help and allows us to help them access the services in, and beyond, the school.

Pastoral support needs are met initially by the class teacher, however, pupils needing more specific support can be referred by the class teacher.

Our dedicated team of teaching assistants are deployed by the SENDCo based on supporting the various needs of our pupils. Further information can be found in our SEND Offer.

#### PREVENT TRAINING - Radicalisation.

Mrs Gallinagh has received PREVENT training and has trained the team on how to identify the early stages of radicalisation and what to do. We follow the mantra; NOTICE CHECK SHARE.

#### **Child Sexual Exploitation and Child Criminal Exploitation**

All staff at St John's C of E Middle School Academy have been trained to identify early cases of child sexual or criminal exploitation. At school we use the <u>Get Safe risk assessment and processes</u> if we have concerns.

#### Female Genital Mutilation (FGM)

All staff have received training on FGM. Teachers know how to identify if a child may be at risk. They know the signs to look for and most importantly how to refer, following the schools safeguarding procedures. At St John's C of E Middle School Academy we meet the needs of our children through a variety of ways:

- Closely monitoring and having conversations about Attendance
- Safeguarding processes of reporting and building up a picture
- Behaviour for Learning
- Pastoral Support where changes and needs are noted
- Speaking to parents and building positive relationships
- SENCO support
- Designated Safeguarding Lead who can see the full picture of concerns raised (DSL)

At St John's C of E Middle School Academy we meet the needs of our children through a variety of ways:

Pupil Voice – pupils are actively encouraged to speak about any concerns they have to a member of staff or to our pastoral team. In lessons children are taught to speak openly about their emotions. Pupils know the staff take all their concerns very seriously.

- Children's questionnaires ascertain if they feel happy and safe
- Epraise facility for pupils to 'Report a Concern' on 'Wellbeing', 'bullying' or 'something that they want their teacher to know.'
- Our PSHE and RSE Curriculum
- E-safety assembly delivered to all pupils
- E-safety presentation offered to parents
- Assemblies for E-Safety, Sexting and other relevant topics are conducted by school staff or external agencies.
- A recovery system where pupils are spoken to when things are not going well for them.
- Delivery of support groups tailored for our children's needs
- Our school council have a huge role in pupil voice and they meet with Mrs Elwell
- Staff CPD around pupil wellbeing and how to support them.
- Senior Leadership Team presence during less structured times
- School nurse referrals and discussions to discuss pupil wellbeing to pupils.
- Attendance of meetings with community school and police group, on a termly basis

#### **Attendance**

Mrs Keen is the Attendance Officer, supported by Mrs Lloyd (Pupil Premium Mentor) and overseen by Mrs Birmingham (Assistant Headteacher). She, and heads of year, and Mrs Gallinagh, monitor attendance regularly and follow our Attendance Policy (on the school website) to support pupils and families where attendance is becoming concerning. The aim is to offer help and solutions to any problems. Parents can access their child's attendance live via Epraise. The school operates a first day response system.

#### Safeguarding

- All teachers and staff know how to identify and report concerns, via staff training on induction and our regular updates on safeguarding.
- Child protection files are kept in an electronic secure format or in a lockable, fire proof cabinet.
- The Attendance team follow missing from education guidance.
- All new staff complete safeguarding inductions.
- We have a designated teacher for children in care and those who are Previously Looked after.

• We have a record of annual recording that all staff have read the relevant sections of 'Keeping Children Safe in Education'.

#### Behaviour for Learning at St John's C of E Middle School Academy

- The school encourages and rewards pupils using Epraise on a lesson by lesson basis
- Pupils are rewarded by events and other entitlements can be purchased and awards given through Epraise for meeting certain criteria.
- Recovery staff have received MAPA De-escalation training
- Emotional Literacy Support assistant runs support groups where needs are identified
- Trauma Informed practitioners support where concerns are raised
- Landscape of the Mind (TIS) forms part of every child's PSHE curriculum to identify and support.

Our school Behaviour and Relationships Policy is followed by all staff for pupils displaying unwanted behaviours.

Parents can access their child's behaviour for learning record via Epraise.

#### Pastoral Support

Allocated staff work with pupils and families to support their needs whilst also signposting them to relevant agencies. With families consent, we can refer families for further family support in the form of Early Help or Targeted Support (Click for details)

#### **SENDCO**

Ms Jarvis works with children and families with additional needs and can signpost parents to many different agencies.

#### **Designated Safeguarding Lead (DSL)**

The DSL (Mrs Gallinagh) ensures rigorous and robust systems are in place within the school to ensure the safety of all of our children.

In **Keeping Children Safe in Education 2023,** it makes it clear that ALL staff should be aware of their local early help process and understand their role in it. In addition, this statutory document makes it clear that any child may benefit from early help, but all school and college staff should be particularly alert to the potential need for early help for a child who:

- Is disabled and has specific additional needs;
- Has special educational needs (whether or not they have a statutory education, health care plan); Is a young carer;
- Is showing signs of being drawn in to anti-social or criminal behaviour, including gang involvement and association with organised crime groups;
- Is frequently missing/goes missing from care or from home;
- Is misusing drugs or alcohol themselves;
- Is at risk of modern slavery, trafficking or exploitation;
- Is in a family circumstance present challenges for the child; such as substance abuse, adult mental health problems or domestic abuse;
- Has returned home to their family from care;
- Is showing early signs of abuse and/or neglect; Is at risk of being radicalised or exploited; Is a privately fostered child.

Everyone needs help at some time in their lives and therefore an ethos of early help is important for any school or PRU.

The coordinated St John's C of E Middle School Academy offer of Early Help is outlined in the table below. We believe that early interventions for children or families, in many cases, will prevent children from experiencing harm.

All St John's C of E Middle School Academy staff must be aware of the school offer of early help. At all times, staff should consider if there is any offer of early help that we can make in order to help a child thrive.

We also liaise with other agencies and people within the local community. In the table below are some National organisations that can support children, young people and their families

#### Home-school support Home education is becoming an increasingly popular option for some families but this must be carefully considered. (Government guidance) In Worcestershire and we have a growing community that are able to offer each other support. Between us we have years of experience in educating children of all ages and are able to organise and put Worcestershire Elective on a range of activities. Home Education Network We hold meetings usually at least weekly, throughout term time at various locations round the county-for example: Social gatherings occur monthly in North Worcestershire for all ages, with both indoor and outdoor games plus organised activities such as climbing/zipwires/grass sledging for 8+. Monthly meeting in Worcester with games, music and crafts for all ages. Monthly social meeting in south Worcestershire, including indoor and outdoor games, group music session and a drama group. Bowling or Ice skating most months. "Education group" workshops organised regularly. Recent workshops have include: Marvellous Mosaics' 'Gunpowder plot' 'Medieval life', 'Making Music' and 'Creative Writing. We also meet up with people from neighbouring counties and many of us go along to the national camps and gatherings that are organised by home educators throughout the year. We have a Worcestershire Home Educators Newsletter (WHEN) that lists all of the activities for the coming month and run a Worcestershire Home Educators Internet support list. #### **Harmony At Home**

Parental conflict, which can range from a lack of warmth and emotional distance, right through to swearing and shouting, is known to be a risk factor for poor child outcomes, particularly when conflict is frequent, intense and poorly resolved. ## Bullying (including cyberbullying)/ Child death/suicide/prevention

**Cyberbullying** is using the internet, email, online games or any digital technology to threaten, tease, upset or humiliate someone else.

If the police consider a message or post to be potentially criminal, they will take appropriate action. This could involve arresting the person responsible or interviewing them under caution. Cases involving sustained abuse or where someone's life is threatened will be treated seriously. The police will consider all of the circumstances when considering the best response to a report of cyber bullying. They will assess how vulnerable the victim is and what resources are required to trace the offender via social networking sites that often operate abroad and to different legislation. In certain cases, it may be difficult to take action if the offender isn't in the UK. They will work with the victim to bring about the most suitable and proportionate conclusion, this will include alternative options that include the officer in the case using their discretion and working with the offender to record an apology to the victim.

There would have to be evidence of racial slurs or racial statements in addition to the crime (this does not trivialise other serious offenses that are NOT hate crimes).

## Children with disabilities team (CWD)

The Children with Disabilities (CwD) Social Work Team provide services designed to meet the needs of children and young people who have complex disabilities.

The CwD Social Work Team is one of a range of services that can provide support to children and young people with disabilities and their families. Other services available are those provided by health, education, play and youth services as well as community resources provided by voluntary agencies.

The CwD team offer services to those children and young people requiring additional resources in respect of their disability, where the disability has a profound impact on the child or young person's life.

An assessment will be offered where the child has a condition which is substantial, long lasting or permanent, is a physical and/or learning disability or a life limiting, life threatening condition. These may include:

- · severe learning disabilities
- severe physical disabilities
- severe developmental delay in motor and or cognitive functioning
- · profound multiple disabilities
- severe sensory impairment (registered blind and/or profoundly deaf)
- complex and severe health problems that arise from the disability, that are life threatening, degenerative illness or organic disorder resulting in severe disability
- a diagnosis of Autistic Spectrum Condition with an associated learning disability and where the condition severely affects day to day functioning SEN Services and Support Groups

- Any young person can be targeted but there are some particularly vulnerable groups: Looked After Children, Children Leaving Care and Children with Disabilities.
- Victims of CSE may also be trafficked (locally, nationally and internationally).
- Over 70% of adults involved in prostitution were sexually exploited as children or teenagers.
- Sexual violence or abuse against children represents a major public health and social welfare problem within UK society, affecting 16% of children under 16. That is approximately 2 million children.

#### **Domestic Violence Protection Order (DVPO)**

DVPOs are a civil order that can be applied for by the police and granted by a magistrate. If granted, the order will immediately ban the perpetrator from returning to a residence and from having contact with the victim for up to 14-28 days. This period of time allows the victim the opportunity to consider their options and allows agencies to provide intensive support to the victim / family. This

Protection Order does NOT need the consent of the victim. A breach will result in the perpetrator being arrested. These Orders can be used proactively and you don't have to wait for the offender to commit another offence. Find out more at: https://bit.lv/2GPG8Oi

A free app for smartphones has been designed to protect both men and women from possible danger. Hollie Guard turns your smartphone into an advanced personal safety device at the touch of a button. If in danger simply shake your phone generate an alert, your location, audio and video evidence of the incident will automatically be sent to your emergency contact via text and email. Shake it again and it sends out a high pitched alarm and the flash starts to strobe, in order to attract maximum attention. From the moment Hollie Guard is activated, your location is tracked and can be viewed in real time by your emergency contact. Evidence is not stored on the smartphone but on secure servers so that it can be used as future as evidence. Hollie Guard also contains many other features.

## Honour based violence (HBV)

Honour' based violence (HBV) occurs when perpetrators believe a relative or other individual has shamed or damaged a family's or community's 'honour' or reputation (known in some communities as izzat), and that the only way to redeem the damaged 'honour' is to punish and/or kill the individual. 'Honour' based violence is a term that is widely used to describe this sort of abuse however it is often referred to as **so called 'honour' based violence** because the concept of 'honour' is used by perpetrators to make excuses for their abuse. There is a very strong link between 'honour' based violence, forced marriage and domestic abuse. The term 'Honour Based Violence' is the internationally recognised term describing cultural justifications for violence and abuse. Honour Based Violence cuts across all cultures and communities: Turkish, Kurdish, Afghani, South Asian, African, Middle Eastern, South and Eastern European for example. This is not an exhaustive list. Where a culture is heavily male dominated, HBV may exist. The police have made it a high priority to help communities fight back to tackle both honour-based violence and hate crime.

Female Genital Mutilation (FGM) comprises all procedures involving partial or total removal or the external female genitalia. FGM is illegal in the UK and as of October 2015 mandatory reporting commenced. If education staff or other professionals discovers that an act FGM appears to have been carried out on a girl under 18 years

old there is a statutory (legal) duty on teachers for them PERSONALLY to report it to the police.

Children Missing in Education (CME)	Children Missing Education (CME) refers to 'any child of compulsory school age who is not registered at any formally approved education activity eg school, alternative provision, elective home education, and has been out of education provision for at least 4 weeks'. CME also includes those children who are missing (family whereabouts unknown), and are usually children who are registered on a school roll / alternative provision. This might be a child who is not at their last known address and either has not taken up an allocated school place as expected, or has 10 or more days of continuous absence from school without explanation, or left school suddenly and the destination is unknown. In some cases, missing adults may have made a choice to leave and 'start their lives over again', but the vast majority of missing people, children and adults, are vulnerable and need protection and support. The strategy has three key objectives which provide the right foundations for any effective local strategy to tackle this issue: Prevention - reducing the number of people who go missing, including through prevention strategies, education work and early intervention in cases where children and adults repeatedly go missing Protection - reducing the harm to those who go missing, including through a tailored, risk-based response and ensuring agencies work together to find and close cases as quickly as possible at a local and national level Provision - providing support and advice to missing persons and families by referring then to agencies promptly and ensuring they understand how and where to access help.
